Canterbury/Wests enjoyed a good season achieving a good aggregate of wins with 1 team (U13) in the Youth Championships making the semi-final. I wish to thank the players, coaches and managers of each of the representative teams, and to our rep convenor Dinesh Divikar for their efforts during the year. Dinesh is also very ably supported by Anna Mori and Carla Bereham who have a done a great job with the sponsorship and organisation for the rep teams. The C&WSCA Treasurers Report Season 2024/2025

The Association recorded an operating loss of \$6,313.37 for season 2024-25 this was a result of the increasing costs of running our competition & representative programs while continuing to maintain our \$100 per team Covid relief discount which has become unsustainable.

Ground hire fees paid by the C&WSCA will continue to increase as we have been advised by Burwood, Canterbury Bankstown and Inner West Councils of their increased ground hire rates.

Kookaburra provided the C&WSCA \$3,000 in sponsorship an increase of \$500. While Anna and Carla our reps Mums continued their outstanding fund raising efforts with grants, raffles, sausage sizzles at Bunnings, new and returning sponsorships for our representative teams.

Thank-you to all our new and returning representative team sponsors for their financial support in 2024-25

First Class Cricket (\$7,000), Nice Bite Dental (\$2000), Salim Nets (\$1575) and Rene Valencia (\$985).

The Inner West Council and Wests Ashfield Leagues Club each granted \$5,000 to our representative teams program for a total of \$10,000, thanks to Anna & Carla's applications.

The representative player fees raised in season 2024-25 combined with our representative fund raising, grants team sponsors funds and the C&WSCA contribution, covered the coaching, gear, training and uniforms expenses of our representative team programs.

Our season 2024-25 financial year loss of \$6,313.37 is an indicator that we can no longer continue providing our Clubs with the \$100 per team financial relief as we started during Covid and continued through to season 2024-25.

Explanation notes for Profit and Loss Statement

Our season 2024-25 loss of \$6,313.37 is a result of the increasing costs of running our competition and representative programs while continuing to maintain our \$100 per team Covid relief discount which has become unsustainable.

Representative Income and Expenses

Representative fees income includes Winter Development and Representative season fees collected from players, fund raising raffles, sausage sizzles at Bunnings BBQs, grants from Inner West Council and Wests Ashfield Leagues Club plus our representative team sponsors, to cover expenses including, payment for cricket equipment, representative clothing, training gear, and programs, trophies, award night functions, photos and winter development training.

Winter development costs run over 2 financial years, with income being received in the previous financial year and costs being paid during the current financial year. In season 2024-25 The C&WSCA contributed by paying for some of our representative team expenses.

Representative expenses stabilised in season 2024-25 with some savings on clothing, while coaching fees were the same as last season. These costs were covered by the fees each player paid plus the marvellous fund raising efforts Anna and Carla as stated in the Treasurer's report.

Administration Costs

These are the everyday costs of running the association namely, phone, internet, paper, printing and the like as incurred in the normal course of association business plus purchases of laptops, printers, mobile phones and internet bill payments as required by the Secretary, Treasurer and our executive committee from time to time.

Clubs Fees

Income received includes affiliation, ground fees, registration, bonds and fines for both senior and junior teams for the season. This income is used to pay for Councils Ground Hire Invoices, Umpires Fees and some of the other administration costs of the C&WSCA.

Association Phone Account

This amount represents the cost of the Association land line, internet connection and the Secretary's iphone 14 mobile phone purchase in 2023 and his iphone 16 purchased in season 2025 plus internet bills which has been included in Administration costs as approved by our auditor since 2015 to date.

 - o \$7,500 from First Class Cricket
 - o \$5,000 sponsorship from West Ashfield (Second year)
 - \$11,200 from NSW Government grant (Used fully for Winter development)
- Revisited Clothing and appointed Cherry Apparel with savings achieved (\$ 50/kid).
 - The feedback was excellent.
 - Saved money on hats (Baseball type Cost recovered in first year itself).
- One time proposal for Clothing approved by Executives for Winter development (6K).
- We had first class Cricket deliver Winter development for U12- U15 & Rising Stars Academy U11.It was very beneficial and we could see the difference at trials.
- Nominated Asher Beheram, Benji Beheram, Spenser Alt for Holman Barnes group sports person award for their selection & achievement (Grand final) NSW Under 14 State Indoor Championship.
- Nominated Kaito Mori for his State Merit Team selection in Under 12 NSW PSSA Championship.
- We have good stock left from last season and Representative financials are very healthy as compared to previous season in excess of \$7000 before start of the season in cash.

Anna and Carla's dedication has been phenomenal, and we are committed to supporting their ongoing efforts to keep representative cricket affordable for families and invest in professional coaching for player development through sponsorship.

We need to ensure that we can start transitioning with new parents in the coming season. To be discussed as part of next season. We have started discussions with potential people.

Season Achievements & Highlights (2024/2025)

NSW Youth Competition

- Finals: Only one out of five teams reached the finals (U13 Div 1 Gee Shield).
- Challenges: Batting & Fielding, playing spin needs improvement across age groups. Wicketkeeping was another issue in most teams as we are lacking boys who want to keep. Part timers aren't the solution.
- **Performance**: Competitive in most rounds across teams, with notable performances in the Cawsey Shield, Gee Shield, Moore Shield and Weblin Shield.
- **Moore Shield**: First year playing on turf was tough with few promising individual performances.

IDCA/President's Cup

- **Teams**: Fielded one Under 11 team (Division 1) due to lack of quality Representative players unlike previous years.
- **Performance**: Competitive but had tough season. Hoping they have learned a lot and improve performance in seasons ahead.

Individual & Team Highlights

- U13 (Div. 1) Semi Finals: Top 2 finish in the rounds and reach the Semifinals.
 - Asher Beheram, Benji Beheram, and Nikhil Puranik were selected as Green Shield players.
- U14: Notable performances from Wahaab Afzaal & Harry Bugden led them to be selected for State Carnival.
- U15: Competitive in a few games but fell short overall. Should have qualified but missed out with few tight losses.
- Player of the Year Awards:
 - o NSW Youth: Wahaab Ahmad (300 points)
 - o President's Cup: Champion Palyer Kaveen Muraleetharan (246 Points)
- Participation and Recognition: Every player will receive a participation trophy. Round and season awards were given for best batsman, bowler, and all-round performance. This year we had a delay with my non-availability and competing priorities. We are planning to do this in August as a combined event.
- Historic Achievement Awards:
 - o Batting: Lawson Fabo (100 no) Cawsey Shield against SSJA
 - o Bowling: Harry Bugden (7-3-9-5W) against Bankstown
